New Priorities

SHIFT 2014-2020

- **Increased focus on threats to law and order, security and safety of individuals, critical infrastructure, public health, climate change (2/3 of the budget)**
- **And less on CBRN Risk Mitigation (1/3 of the budget)**

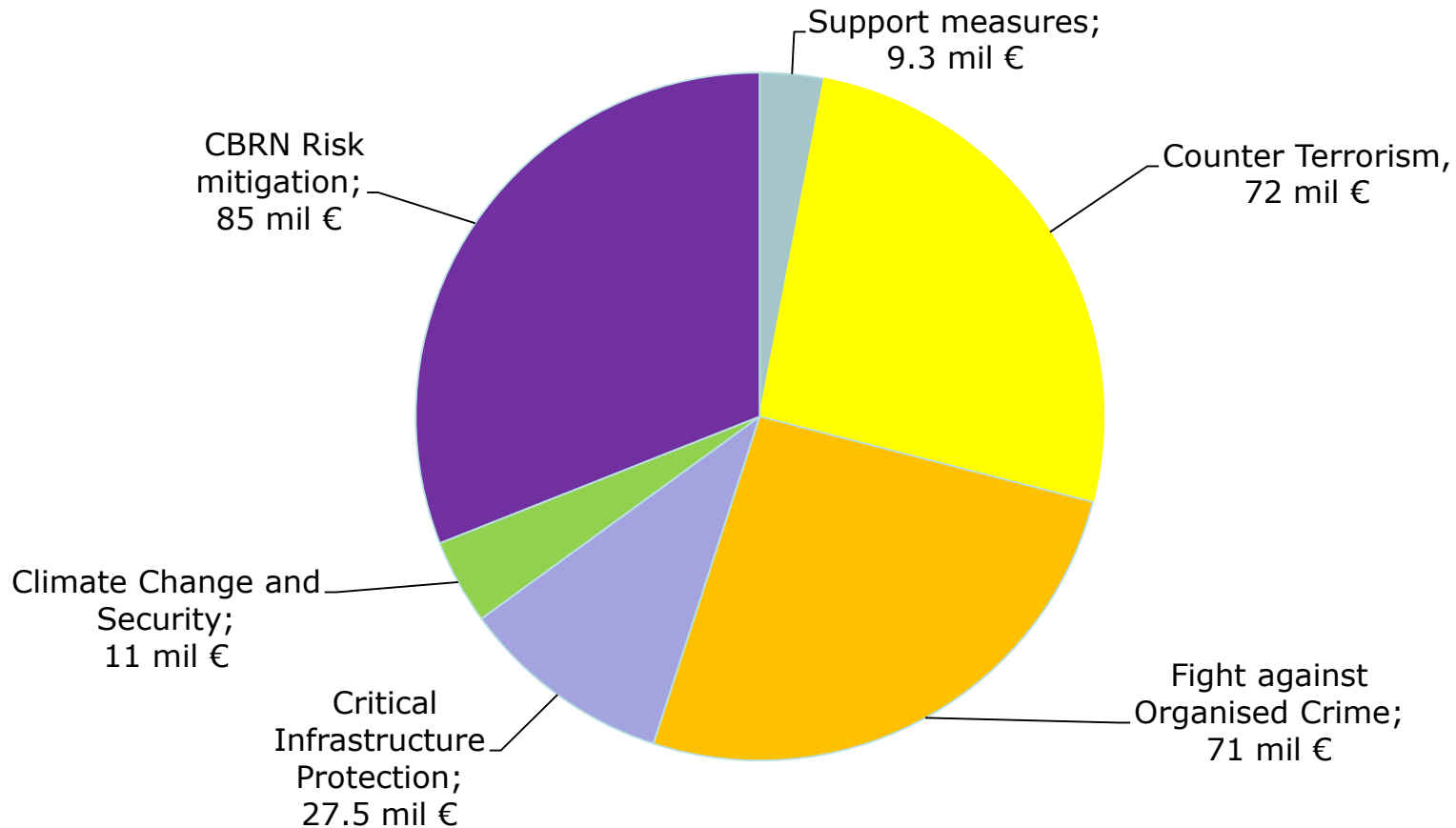

IcSP Article 5 (2014-2017)

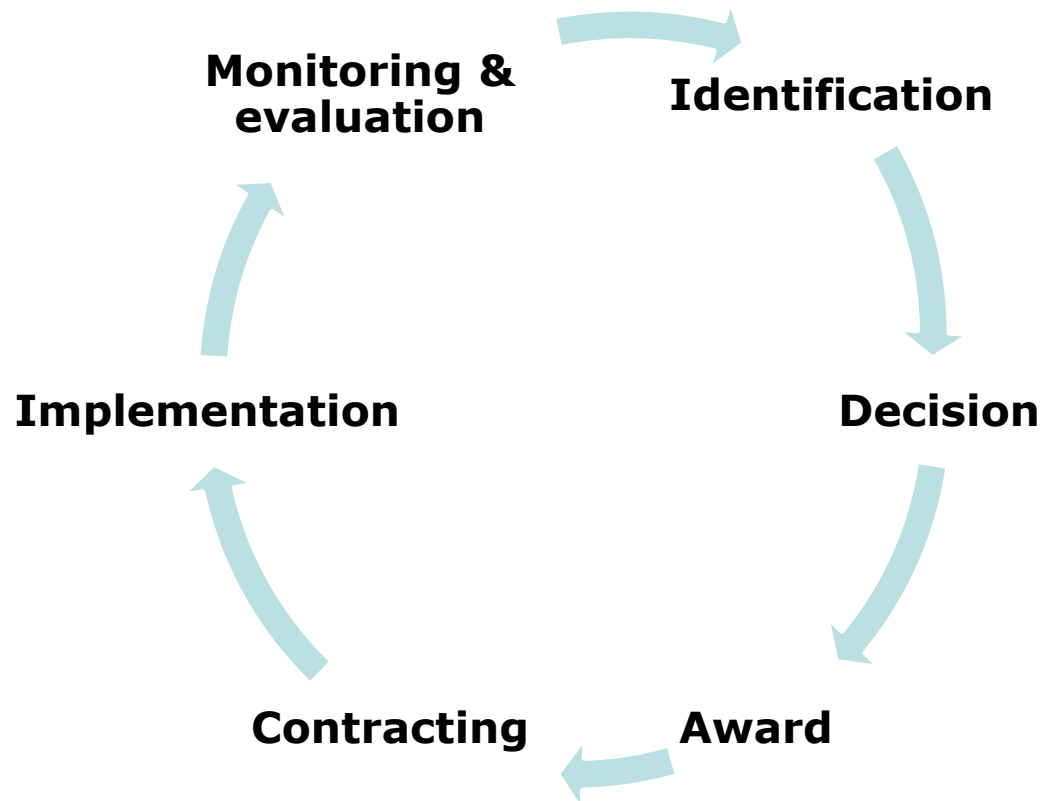

IcSP 2016 – Counter-Terrorism Overview

The objective is to **disrupt terrorist networks & activities** of recruiters, **cut off terrorist funding** and **bring terrorists to justice** while respecting human rights and international law.

Priority actions:

- AML/CFT
- Criminal justice/Prison de-radicalisation
- CT Pakistan

IcSP 2016 - AML/CFT

This is a global facility of EUR16M aimed at **Anti-Money Laundering** (AML) and **Countering the Financing of Terrorism** (CFT) in line with the priorities defined in the Strategy and MIP of the IcSP.

We are currently in the Identification & Formulation stage of the process in defining the parameters and geographic scope of the new action taking into account existing initiatives.

IcSP 2016 - Criminal justice/Prison de-radicalisation

The focus will be on strategies and programmes to **reduce the risk of radicalisation** to terrorism in prisons.

This is likely to include a **compendium of good practices** as well as **pilot projects** in specific countries.

We are currently in the Identification & Formulation stage of the process and exploring co-financing arrangements with the UN.

IcSP 2016 – CT Pakistan

The objective is to **support national capacity** in the fight against terrorism and organised crime networks.

Builds upon an ongoing IcSP project that aims to improve the ability of Punjabi agencies to **successfully investigate, prosecute, convict and detain terrorists.**

The specific purposes are e.g. to increase the use of forensic evidence, to improve the quality of the evidential packages, increased understanding of forensic evidence, and improving professional relations between police and prosecution services.

IcSP 2016 - Illicit Trafficking The Cocaine Route Programme

The Programme's objective is to **strengthen partner countries' capacities** in their efforts to **fight organised crime and drug trafficking** and encourage South-South cooperation (LAC and Africa)

The programme's activities span to three main domains:

- **interdiction of illicit drugs,**
- **anti-money laundering and**
- **information sharing.**

IcSP 2016 - Smuggling of migrants (SoM) incl. Trafficking in Human Beings

In light of the migrant crisis, the IcSP can bring added-value with its trans-regional scope tackling SoM from the **organised crime perspective** and thereby contribute to the implementation of the EU Action Plan against migrant smuggling.

We are currently in the Identification stage of the process and defining the geographical scope of a new EUR 5 million action, in order to best complement the ongoing and planned actions under other instruments (DCI, EDF, ENI, DCI-GPGC).

IcSP 2016 - AIRCOP IV

West Africa has become one of the **main transit areas for cocaine trafficking** from Latin America and the Caribbean to Europe.

AIRCOP (Airport Communication Project) aims to

- **combat drug trafficking by air** and
- build **drug-interdiction capacities at selected airports** in Africa, Latin America and the Caribbean.

AIRCOP is based on the cooperation between UNODC, INTERPOL and the World Customs Organization.

IcSP 2016 – Critical Infrastructure

Single area of focus for 2016: Cybersecurity

Cybersecurity became a new priority area of action under the IcSP since 2013.

IcSP follows the EU approach to cyber capacity building as defined in the **2013 EU Cybersecurity Strategy** and **2015 Council Conclusions on Cyber Diplomacy**

IcSP 2016 - Cybersecurity

We are currently in the process of refining the objectives and identifying the priority countries of a new 11MEUR action. Main objectives shall include:

1. Supporting the set up/development/training of Computer Emergency Response Teams (CERTs) and 24/7 Contact Points
2. Advising for the development of National Cyber Security Strategies
3. Promoting effective cooperation through enhanced Private Public Partnerships and exchanges at international level
