14h05 . 15h30	<p>Session 1: Italy's approach to EU foreign policy: what priorities for EU peacebuilding and conflict prevention ahead of the Italian Presidency of the EU?</p> <p>Three years after its creation, the European External Action Service (EEAS), in charge of defining and implementing the EU's external action, has had a significant role in developing conflict policy and mediation expertise within its own structure. It is undergoing a review process which gave the opportunity to Member States to express their vision for EU foreign policy and peacebuilding activities. Traditionally, Italy has been an advocate for a stronger role of the EU in foreign policy, especially when it comes to the European neighborhood. In July 2014, Italy will take on the presidency of the EU for six months.</p> <p>Issues to be addressed:</p> <ul style="list-style-type: none"> • What is the state of play regarding EU conflict prevention and peacebuilding policy and practice? • How does Italy view its role in EU foreign policy and how can it strengthen the EU as a peacebuilding actor?
