# Nagorno-Karabakh: Continuing EU support for building peace – Gathering civil society input

## CONCEPT NOTE

### Background

The European Partnership for the Peaceful Settlement of the Conflict over Nagorno-Karabakh (EPNK) is a major initiative funded by the EU through the Instrument contributing to Stability and Peace (IcSP). Since 2010, it has supported 'peacebuilding efforts concerning the conflict over Nagorno-Karabakh by facilitating dialogue between civil society, media and policy-makers.'<sup>1</sup>

The second phase of the EPNK is coming to an end but the EU is committed to continuing its support to the Nagorno-Karabakh conflict settlement process. In this context, the European Peacebuilding Liaison Office (EPLO) has been requested to organise a meeting in the framework of the Civil Society Dialogue Network (CSDN) with representatives of peacebuilding civil society organisations (CSOs) working in the region.

### Objectives

The overall objective of this meeting is to gather analysis and recommendations from civil society on the action required to advance the Nagorno-Karabakh conflict settlement process. The outcome of this meeting will feed into the design of future EU assistance to this process.

The specific objectives are:

- To analyse the current context of the Nagorno-Karabakh conflict settlement process
- To share lessons learned from the implementation of projects in the region, in particular the EPNK
- To provide recommendations on what future activities should be envisaged to advance the Nagorno-Karabakh conflict settlement process, in particular civil society-led initiatives, which could then be considered for EU support.

### Participants

The meeting will bring together 20-30 participants, including up to 20 representatives of peacebuilding CSOs working in the region, and officials from the European Commission (EC) and the European External Action Service (EEAS).

### Format

The meeting will consist of three sessions of facilitated discussion between CSO representatives and EU officials.
