

## Civil Society Dialogue Network

### France and the implementation of the EU Global Strategy: A look at conflict prevention and economic diplomacy

Monday 13 March 2017 (14h00 – 19h00)

#### Background:

Fifteen years after the adoption of the EU Programme for the Prevention of Violent Conflicts (also known as the 'Gothenburg Programme') and almost ten years after the Lisbon Treaty enshrined conflict prevention as a key goal of the EU external action, the EU Global Strategy on Foreign and Security Policy provides a major opportunity for the EU and its Member States to close the implementation gap in its support to conflict prevention.

This meeting will look at the implementation of the EU's commitments on conflict prevention, with one session looking at the state-of-play after the publication of the EU Global Strategy and a second one looking particularly at the EU's role in addressing the economic dimensions of conflicts. Recommendations will focus on improving the practice and the impact of EU external action in fragile and conflict-affected countries.

#### Objectives:

The overall objective of this meeting is to gather analysis and recommendations from civil society on making the EU commitments on conflict prevention operational.

The specific objectives of this meeting are to:

- Analyse the EU Global Strategy and its commitments for conflict prevention
- Analyse and gather recommendations on the role of the EU and its Member States, France in particular, in addressing the economic dimensions of conflicts

**Format:** Each session will start with a panel of representatives from the French Ministry of Foreign Affairs, EU institutions and civil society. Facilitation will support interactive discussion with the other participants. The meeting will be held under the Chatham House Rule. Simultaneous translation in French and in English will be provided.

**Participants:** The meeting will bring together 30 participants, including officials from the French Ministry of Foreign Affairs and EU institutions, as well as representatives of civil society organisations (CSOs).

#### **The Civil Society Dialogue Network:**

The Civil Society Dialogue Network (CSDN) is a mechanism for dialogue between civil society and EU policy-makers on issues related to peace and conflict. It is co-financed by the European Union (Instrument for Stability). It is managed by the European Peacebuilding Liaison Office (EPLO), a civil society network, in co-operation with the European Commission (EC) and the European External Action Service (EEAS).
