EU IN THE WORLD UPDATE

Council of the EU: The Foreign Affairs Council (FAC) met on 20 June in Luxembourg. EU foreign ministers discussed and adopted conclusions on Sudan, the European Neighbourhood Policy (ENP), Albania, Belarus, Syria, Libya and Yemen, and endorsed the EU's comprehensive approach towards Sudan and South Sudan. They also welcomed the ENP Review - which was presented by High Representative (HR) Ashton and the European Commission (EC) - and both the establishment of the Task Force for the Southern Mediterranean and HR Ashton's proposal for an EU Special Representative (SR) for the Southern Mediterranean region.

Finally, the FAC adopted conclusions on conflict prevention. Several months after the review of the EU Programme for the Prevention of Violent Conflict (Gothenburg Programme) was put on hold, EU foreign ministers agreed on the need to strengthen early warning and partnerships with the UN, the OSCE, NATO, the World Bank, the African Union and other international actors; and to take early action to mitigate the risks of outbreak and recurrence of conflicts. Although they did not adopt any firm commitments for implementation, they did agree to revisit the issue of conflict prevention by the end of the year.

An informal meeting of EU development ministers took place on 14-15 July in Sopot, Poland. On the agenda were the EU's preparations for the upcoming Fourth High-level Forum on Aid Effectiveness, the programming of EU development aid, EU financing instruments, and the division of labour in Central Asia and (possibly) the Pacific.

The General Affairs Council (GAC) met on 21 June in Luxembourg. Ministers discussed preparations for the June meeting of the European Council which is due to discuss, *inter alia*, migration issues, the Southern Mediterranean and accession negotiations with Croatia.

European Council: The European Council met on 23-24 June in Brussels. EU heads of state and government discussed and adopted a declaration on developments in the EU's Southern Neighbourhood, set orientations for the development of the EU's migration policy and agreed that the accession negotiations with Croatia should be concluded by the end of June 2011.

High Representative (HR): On 6-7 June, HR Ashton chaired the tenth ASEM (Asia and Europe) ministerial meeting in Gödöllő, Hungary. Also on 7 June, she announced the establishment of a new task force for the Southern Mediterranean, consisting of representatives from the European External Action Service (EEAS), the EC, the European Investment Bank, the European Bank for Reconstruction and Development and other international financial institutions.

On 9-10 June, HR Ashton participated in the 27th EU-Russia summit in Nizhny Novgorod, Russia.

From 16-19 June, she travelled to Jordan, Egypt, Israel and the Occupied Palestinian Territories

for meetings with government leaders and international partners, including the UN, the Arab League, the African Union and the Organisation of the Islamic Conference.

On 6 July, she participated in the European Parliament's plenary debates on the situations in Syria and Yemen, the EU's external policies in favour of democratisation, and the situation in Nagorno-Karabakh.

On 9 July, she travelled to South Sudan to participate in the independence day celebrations.

On 11 July, she participated in the Middle East Quartet ministerial meeting in Washington DC.

On 15 July, she participated in the Libya Contact Group meeting in Istanbul.

European External Action Service (EEAS): On 17 June, HR Ashton announced the appointment of Maira Mora (Latvia) as the Head of the EU Delegation to Belarus.

On 20 June, she appointed Christian Berger to the post of EEAS Director for North Africa, the Middle East, the Arabian Peninsula, Iran and Iraq. Mr Berger (Austria) is currently Head of the EU Office for the West Bank and the Gaza Strip.

On 5 July, the Political and Security Committee decided to appoint Andrzej Tyszkiewicz as Head of the EU Monitoring Mission in Georgia. Mr Tyszkiewicz (Poland) is the former Polish ambassador to Bosnia and Herzegovina.

THE EU'S MULTIANNUAL FINANCIAL FRAMEWORK 2014-2020

Introduction

On 29 June 2011, the European Commission (EC) published its proposal for the next EU multiannual financial framework (MFF). This marked the beginning of a negotiation process which could last until the end of 2012 and which will eventually determine the size and allocation of the EU budget until 2020.

A short analysis of the EC's proposal and its implications for the future of EU support for peacebuilding and conflict prevention are set out below.

What is the MFF?

The MFF sets out the maximum amounts ('ceilings') for each broad category of EU expenditure. One (small) category ('heading') is external action ('Global Europe'). It covers the EU's foreign and development policies, including both the activities which the EU undertakes itself and the funding which it provides to other actors.

The EC's proposal consists of two communications and an accompanying 'staff working paper'. It sets out the principles underpinning the EU budget, ceilings for expenditure under each overall heading and proposals for the next set of EU funding instruments (programmes).

What are the implications for peacebuilding and conflict prevention?

The negotiations over the MFF will result in the establishment of a new set of EU external instruments to replace geographical instruments such as the Development Cooperation Instrument (DCI), the European Neighbourhood and Partnership Instrument (ENPI) and the Instrument for Pre-accession Assistance (IPA); and thematic instruments such as the Instrument for Stability (IfS) and the European Instrument for Democracy and Human Rights (EIDHR).

The specific objectives of and amounts of funding under the new instruments could have a major impact on the EU's ability to uphold its commitment to promote peace and prevent violent conflicts around the world. The EU institutions and Member States have a rare opportunity to ensure that, in future, all EU development assistance is implemented in a conflict-sensitive manner and supports those objectives.

What is EPLO's position on the MFF?

In March 2011, EPLO published a position paper on the next MFF in which it set out the following recommendations:

1. Increased funding for external actions
2. Commitment to conflict sensitivity in all EU external policies and programmes
3. Inclusion of peacebuilding and conflict prevention throughout the EU's external actions
4. Increased funding for the IfS (including the Peacebuilding Partnership)

5. Multi-stakeholder partnerships for peacebuilding and conflict prevention
6. Simplification of regulations governing the EU's external programmes and rules governing the management of EU grants

What does the EC's proposal contain?

On the basis of an initial analysis of the communications and the staff working paper, it appears that the EC is proposing, *inter alia* to:

- Increase the **overall EU budget** for the period 2014-2020 to € 1025 billion from € 975.777 billion in the current period (2007-2013)
- **Focus** on results, simplification, conditionality and leveraging investment
- Increase the **budget for external actions** (Heading 4: Global Europe) to € 70 billion from its current level of € 55.935 billion
- Increase the funding for the **Instrument for Stability** to € 2.510 billion from its current level of € 2.062 billion (including an increase in the funding for the short-term, crisis response component and removing the ODA-eligibility criteria)
- Maintain the **DCI** and establish under it a **pan-African instrument** to support the implementation of the Joint Africa-EU Strategy
- Maintain a thematic programme for supporting **non-state actors and local authorities**
- Maintain the **IPA** and **EIDHR** but narrow their scopes
- Rename the **ENPI** the European Neighbourhood Instrument and include incentives for 'best performers'
- Keep the **European Development Fund (EDF)** outside the general EU budget but increase the portion of it which is allocated to the African, Caribbean and Pacific group of countries to € 30 billion from € 21.966 billion for the current period (2008-2013); and increase democratic scrutiny over it

What are the next steps?

The Polish Presidency of the Council of the EU is planning to hold an extraordinary conference on the MFF in the autumn. It will bring together representatives from the EU Member States, the EC, the European Parliament and national parliaments.

The EC will publish legislative proposals for the next set of external funding instruments on 7 December.

The next MFF should be adopted by the end of 2012 and the next set of funding instruments are due to start at the beginning of January 2014.

EPLO aims to influence the EU so it promotes and implements measures that lead to sustainable peace between states and within states and peoples, and that transform and resolve conflicts non-violently. EPLO wants the EU to recognise the crucial connection between peacebuilding, the eradication of poverty, and sustainable development worldwide and the crucial role NGOs have to play in sustainable EU efforts for peacebuilding, conflict prevention, and crisis management.

EPLO advances the interests of its members through common policy positions and consequently advocating for those common positions. EPLO disseminates information and promotes understanding of EU policies of concern to its members. The Office also builds solidarity and co-operation amongst its members and with other relevant NGO networks.

Finally, EPLO raises awareness about the contribution the EU should make to peacebuilding and the need to hold the EU accountable to its own political commitments of helping secure peace within and outside its borders.
