# EU UPDATE

#### Council of the EU

The Foreign Affairs Council (FAC) met on 22 July and 21 August. In May, EU foreign ministers adopted conclusions on Bosnia and Herzegovina, Egypt, Mali, Myanmar, Somalia, Sudan and South Sudan; the Great Lakes region and the Democratic Republic of Congo; the Middle East peace process, EU water diplomacy, the implementation of the EU's strategic framework and action plan on human rights; and the role of local authorities in development co-operation. They also:

- debated the situation in Syria
- discussed questions relating to Lebanon and the possible • designation of an entity under the EU's restrictive measures to combat terrorism
- discussed recent developments in the Eastern Partnership countries and the way ahead in the run-up to the third Eastern Partnership Summit (November 2013, Vilnius)
- adopted the EU position for the thirteenth meeting of the EU-Kazakhstan Cooperation Council (July 2013, Brussels)
- took note of the fifth implementation report for Pakistan
- endorsed the six-monthly progress report on the implementation of the EU strategy against the proliferation of weapons of In August, they adopted conclusions on Egypt. They also: mass destruction, covering activities from the first half of . 2013, and allocated € 750,000 from the EU budget to support action against the proliferation of weapons of mass destruction in implementation of UN Security Council resolutions 1540 and 1977
- amended the implementing legislation for the EU restrictive measures against the Democratic People's Republic of Korea, to take account of changes introduced by UN Security Council resolution 2094
- appointed Mr Franz-Michael Skjold Mellbin as EU Special Representative in Afghanistan (see below)
- amended the implementing legislation for the EU restrictive measures against Syria

- approved a position on the arrangements to be followed regarding the conclusion by the EU of memoranda of understanding, joint statements and other texts containing policy commitments with third countries and international organisations
- approved the EU position and draft agenda for the tenth meeting of the EU-former Yugoslav Republic of Macedonia Stabilisation and Association Council (July 2013, Brussels)
- adopted the Council and Commission decision on the conclusion of the Stabilisation and Association Agreement between the European Communities and their Member States, of the one part, and the Republic of Serbia, of the other part
- agreed on a decision on the provision of macro-financial assistance for Kyrgyzstan, up to a maximum amount of € 30 million
- approved two transfers of a total amount of EUR 262.7 million in commitments and EUR 148 million in payments in order to provide humanitarian aid to Syria, the Democratic Republic of the Congo and the Central African Republic.

- adopted by written procedure an extension to Decision 2012/96/EU adapting and suspending the period of application of appropriate measures limiting co-operation with Zimbabwe
- adopted by written procedure an implementing decision implementing Decision 2011/72/CSDP, and an implementing regulation implementing Regulation (EU) No 101/2011, both concerning restrictive measures directed against persons, entities and bodies in view of the situation in Tunisia.

#### Common Security and Defence Policy (CSDP)

On 3 July, the Council prolonged the EU police mission for the Palestinian Territories (EUPOL COPPS) until 30 June 2014, and allocated a budget of € 9.5 million for its activities.

On 19 July, the Political and Security Committee (PSC) appointed Brigadier General Bruno Guibert (France) as the new head of mission for the EU training mission in Mali (EUTM Mali).

On 22 July, the Foreign Affairs Council (FAC) approved the signing and conclusion of an agreement between the EU and Australia establishing a framework for the participation of Australia in EU crisis management operations. It also approved an agreement between the EU and the Republic of Niger on the status of the Common Security and Defence Policy (CSDP) mission in Niger (EUCAP Sahel Niger), and endorsed its conclusion.

On 23 July, the PSC appointed Etienne de Poncins (France) as the new head of mission for the EU mission on regional maritime capacity building in the Horn of Africa (EUCAP Nestor).

On 13 September, the PSC appointed Toivo Klaar (Estonia) as the new head of mission for the EU Monitoring Mission in competitive and efficient defence and security sector. Georgia (EUMM Georgia).

#### **European External Action Service (EEAS)**

On 24 July, High Representative (HR) Catherine Ashton announced the appointment of Chantal Hebberecht as head of the EU Delegation to Ethiopia, and Michael Ryan as head of the EU Delegation to Rwanda.

On 29 July, HR Ashton published the EEAS Review.

On 16 September, the EU and the Somali Federal Government co-hosted the 'A New Deal for Somalia' conference in Brussels. Participants endorsed a New Deal Compact for Somalia and committed to support its implementation.

#### EU Special Representatives (EUSR)

On 22 July, the Council of the EU appointed Mr Franz-Michael Skjold Mellbin (Denmark) as EU Special Representative (EUSR) in Afghanistan. Mr Skjold Mellbin was the Acting Under-Secretary of State for Global Politics and Security in the Danish Ministry of Foreign Affairs and had previously served as Danish Special

Representative for Afghanistan and Pakistan. He will also be the head of the EU Delegation to Afghanistan.

On 16 July, the European Commission (EC) published a communication on a comprehensive and integrated approach to financing poverty eradication and sustainable development.

On 21 August, the EC published the annual report 2013 on the EU's development and external assistance policies and their implementation in 2012.

On 12 September, the EC published the 2012 annual report on financial assistance for enlargement.

#### **European Parliament (EP)**

The European Parliament had plenary sessions on 1-4 July and 9-12 September in Strasbourg.

In July, members adopted resolutions on the political agreement on the next EU multiannual financial framework, further macro-financial assistance for Georgia, arms exports (implementation of Council Common Position 2008/944/CFSP), preparation of the EC Work Programme 2014, and the situations in Djibouti, Egypt and Nigeria.

In September, they adopted resolutions on an EU cybersecurity strategy, the maritime dimension of the CSDP, the EU's military structures, EU policy towards Belarus, pressure exerted by Russia on Eastern Partnership countries, and the situations in Bahrain, the Central African Republic, the Democratic Republic of Congo, Egypt and Syria.

## **REFORMING CIVILIAN COMMON SECURITY AND DEFENCE POLICY (CSDP)**

#### Introduction

This is a summary of EPLO's recent policy paper on civilian Common Security and Defence Policy (CSDP).

The policy paper starts from the position that civilian CSDP is a crucial tool for the EU, in that it can serve as a vehicle for collective action on the part of the EU and EU Member States, however it requires reform to build on 10 years' worth of evidence on how to effectively respond to conflict. It covers the following points:

Integration of CSDP Missions into Overall EU Strategies: CSDP missions should be used as a tool to implement overall EU objectives as set out in a country or regional strategy. This would minimise risks of wasteful and confusing duplication and ensure that the investment made in the CSDP is built on by other EU activities.

Revision of Civilian CSDP Concepts: When civilian CSDP was developed it was a foresighted and cutting edge approach to conflict which has since been taken up by other international actors. However, more than ten years after the first CSDP missions were deployed .it is time to update the concepts underlying the CSDP in order to integrate the wealth of evidence on effective response to conflict which has been generated in the meantime. In this regard, the review of the concept for CSDP border missions is a welcome development. The CSDP could benefit from the experience of individual EU Member States in specific areas, for example, Ireland's expertise in police reform. EU Member States should define their involvement in the further development of civilian CSDP.

Integration of Conflict Analysis into Mission Planning: The planning of CSDP missions should be informed by detailed conflict analysis setting out the causes, actors and dynamics of conflicts within each context. This would help to ensure that missions have a positive impact on the conflict dynamics and would minimise the risks that they inadvertently exacerbate existing tensions. The CSDP could use existing assessment of context carried out within the European External Action Service (EEAS) and the European Commission (EC).

Rigorous and Participatory Evaluation of CSDP Missions: Significant positive steps have been made to improve the evaluation of CSDP missions, notably by the Division for Capabilities, Concepts, Training and Exercises inside the Crisis Management and Planning Directorate (CMPD) and through cautious widening of consultation during strategic reviews. This should continue and should include assessment of the impact of CSDP missions on the context, as well as development of indicators of success and wider consultation of stakeholders, including intended beneficiaries, in evaluation. The European Court of Auditors' report on EU-LEX Kosovo and the study on the Civilian Planning and Conduct Capability (CPCC) Impact Assessment Framework provide suggestions to improve evaluation of CSDP missions.

## and Local Populations

CSDP missions should develop good working relationships with local populations, including civil society as well as government. This would help to improve accountability towards some of the intended beneficiaries of the CSDP, i.e. populations in conflictaffected countries. An effective consultation process, which ensures that local communities' concerns are taken into account in

the planning and conduct of operations, would also improve the missions' understanding of the context in which they are operating and their ability to support the development of security and justice for people. Furthermore, local populations should be adequately informed about the mandate, activities and contingency plans of the missions and made aware of their possible impact so that expectations are realistic and a degree of trust is established

#### **Future Scenarios for Civilian CSDP**

EPLO's policy paper argues that EU policy-makers should consider the different scenarios for the future of the CSDP, including whether the EU should further specialise in particular types of activity in order to avoid duplication and to ensure that capacities are available.

#### **Option 1: Focus on Support for Peace Processes**

The CSDP specialises in specific activities related to monitoring the implementation of peace agreements and to preventing the recurrence of armed conflict or, more ambitiously, supporting peace negotiations.

#### **Option 2: Develop Niche Expertise**

The CSDP further develops its valuable expertise in specific activities such as police training or border management and monitoring by reviewing concepts and practices and integrating lessons learned and other relevant expertise.

#### **Option 3: Develop and Manage Stabilisation Missions**

CSDP missions deploy as short-term stabilisation tools in conflictaffected countries or regions.

#### **Option 4: Explore the Option of Joint EU Missions**

Joint missions encompass a variety of different EU instruments from short-term crisis response mechanisms to longer-term development activity.

#### Option 5: Maintain the Wide Range of Civilian Crisis Management Activities

The CSDP continues with the broad range of civilian crisis management activities that have been developed to date but ensures that the necessary capacity exists in the EU institutions and is deployed by EU Member States to improve effectiveness of the missions.

#### Implications for the December Summit on CSDP

The December Summit on CSDP provides an opportunity for EU Member States to take decisions on civilian CSDP. In the run-up to the Summit, military CSDP has been the focus of extensive debate, sometimes eclipsing the larger civilian dimension. EPLO believes that the agenda needs to be balanced and that the Summit should allow at least equal space for discussion of civilian Improvement of the Relationship between CSDP Missions CSDP. The recent decision of High Representative/Vice-President (HR/VP) Catherine Ashton to include civilian CSDP under the first and second agenda points is welcome in this regard.

> For military CSDP, specific "deliverables" - i.e. decisions to be taken by EU Member States - are on the table, mainly concerning pooling and sharing of resources and funding to the European defence industry.



For civilian CSDP, it has been harder to define similar deliverables; EPLO makes some suggestions below.

Suggested issues for discussion under agenda item ("basket") one:

- Effectiveness of civilian and military CSDP
- Efficiency of CSDP processes

EPLO

- Capabilities required for effective and efficient CSDP
- Integration of the CSDP into an overall EU approach
- Scenarios for the future of the CSDP
- Decisions on priorities for civilian CSDP and areas where the EU can become a world leader and where it should develop niche expertise.

#### Possible Deliverables for Civilian CSDP

#### Effectiveness of Civilian CSDP

- Clarity on EU Member States' expectations for the future of the CSDP
- Decisions on the main lines for the future of the CSDP (scenarios for the future) and its role in overall EU external action
- Acknowledgement by EU Member States of the specificity of concepts for civilian CSDP
- Commitments to review and update the concepts and policy underlying civilian CSDP
- Request to the crisis management bodies to review CSDP concepts and policy and to decide on a list of concepts and respective timeline for review
- Commitments to staff the policy team in the CMPD adequately
- Commitments on the use of conflict analysis in planning missions (using assessment developed in the EEAS and in the EC when possible) and endorsement of a mechanism to integrate conflict analysis into the CSDP
- Endorsement of suggestions on evaluation of CSDP missions, by, for instance, developing indicators for measuring results and impact and providing guidance on involvement of external actors and possible assessment frameworks
- Launch of a framework for evaluation to be applied throughout 2014 and reviewed
- Recognition that civil society is a strategic partner and commitments to enhance further collaboration.

#### Efficiency of CSDP Processes

- List of decisions on improving civilian CSDP processes (see in particular the German non-paper on civilian CSDP)
- Amendment of the Financial Regulation so that money can be dispersed swiftly during the planning phase and for preparatory activities

- Agreement on permanent capacity inside the crisis management structures to support setting up and running of missions
- Standardised templates for basic planning documents to set up missions.

#### Capabilities for CSDP

- Commitment on the part of EU Member States to staff adequately the missions to whose launch they have agreed, including identification and deployment of civilian experts
- Decisions on capabilities in areas of niche expertise where the EU could be a world leader; identification of lead EU Member States for areas of niche expertise
- Commitment to strengthen the policy team inside the CMPD by e.g. seconding additional staff to work on policy and to reinforce co-operation with other parts of the EEAS.

#### Using the EEAS Review

Some of the issues could also be tackled as part of the mid-term review of the EEAS or the debates on it:

- Amendment of the decision which established the EEAS so that the crisis management bodies do not report directly to the HR/VP but are integrated into the rest of the EEAS
- Clarity on role of senior managers in EEAS, including on who is responsible for the CSDP.

#### **Co-operation with Justice and Home Affairs**

The shortfall of civilian capabilities is partly due to the lack of cooperation between the CSDP and the area of justice and home affairs (JHA) in Brussels and at EU Member State level, and the difficulty of convincing ministries of the interior and justice to commit staff to the CSDP.

- Acknowledgement of the link between external and internal security challenges
- Commitment to further develop and implement plans at national level to gain the support of relevant ministries in identification and deployment of mission staff, including recognising benefits and incentives required
- Endorsement of increased co-operation between the Committee of Civilian Aspects of Crisis Management (CIVCOM) and respective working groups in Brussels in line with the roadmap for strengthening ties between the CSDP and the area of freedom, security and justice.
- Request ministries of interior and justice to engage regularly in discussions on the CSDP and to demonstrate their contribution to the CSDP.
