The Foreign Affairs Council (FAC) met on 18-19 November, 12 December and 16 December in Brussels.

On 18-19 November, EU foreign ministers adopted conclusions on Libya, Syria and Tunisia. They also:

- took stock of preparations for the Eastern Partnership summit (28-29 November, Vilnius)
- took stock of the situation in Bosnia and Herzegovina
- received a briefing on the state of play of preparations for the
 16th EU-China summit (21 November, Beijing)
- exchanged views on the latest developments in Egypt
- debated migration issues
- exchanged views on the Common Security and Defence Policy (CSDP) (see below)
- reached agreement on setting the 2014 budget of the European Defence Agency (EDA) at € 30.5 million
- decided to sign and conclude an agreement enabling the Republic of Chile to participate in EU crisis management operations
- noted the report by the Head of the EDA
- took note of the single progress report on the development of
 EU military capabilities November 2012 October 2013
- endorsed a note on EU rapid-response capabilities and EU
 battlegroups
- approved the exercise specifications for the 2014 EU crisis management exercise (MILEX 14)
- approved the conclusion of a protocol to the Association Agreement with the Hashemite Kingdom of Jordan on the

general principles for the participation of Jordan in EU programmes

- adopted the EU priorities for co-operation with the Council of Europe in 2014-2015
- agreed to support the activities of the World Health Organisation (WHO) in the area of biosafety and biosecurity, in the framework of the EU strategy against the proliferation of weapons of mass destruction
- established the EU position for the 12th meeting of the EU-Kyrgyz Republic Cooperation Council (21 November, Brussels)

On 3 and 6 December, they adopted conclusions on the ninth World Trade Organization (WTO) Ministerial Conference.

On 12 December, EU foreign and development ministers adopted conclusions on policy coherence for development, financing poverty eradication and sustainable development beyond 2015, the 2013 annual report on the EU's development and external assistance policies and their implementation in 2012, and EU support for democratic governance. They also:

- exchanged views on how best to support lasting peace and development in the Democratic Republic of Congo (DRC) and the Great Lakes region
- adopted transitional management measures for the European Development Fund (EDF)
- approved a letter to the President of the Republic of Guinea announcing the full resumption of development co-operation between the EU and the Republic of Guinea
- adopted a partial general approach on the decision establishing the European Year of Development 2015.

- received a briefing on the latest round of talks with Iran on its ference. nuclear programme (20-24 November, Geneva)
- debated the latest developments in the Syrian crisis
- discussed the follow-up to the Eastern Partnership summit
- took stock of relations with Russia
- took stock of recent developments in the Western Balkans and discussed foreign policy aspects of the European Commission's (EC) 2013 enlargement package regarding the reaion
- adopted the EU's position for the 11th EU-Morocco Association Council (16 December, Brussels)
- approved the EU's position within the EU-Morocco Association Council with regard to the adoption of a recommendation on the implementation of the EU-Morocco Action Plan implementing the advanced status (2013–2017)
- agreed on EU activities in support of the implementation of the Arms Trade Treaty (ATT), including the allocation of € 5.2 million from the EU budget for projects that aim to support states to strengthen their arms transfer control systems with a view to being able to implement the ATT as well as to increase awareness and ownership of the ATT by relevant national and regional authorities and civil society stakeholders
- authorised the High Representative to open negotiations in order to amend the existing agreement between Australia and the EU on the security of classified information
- took note of the 15th annual report in accordance with Council Common Position 2008/944/CFSP defining common rules governing control of exports of military technology and equipment

The General Affairs Council (GAC) met on 19 November and 17 December in Brussels.

In November, EU foreign and European ministers took note of the EC work programme for 2014, examined a draft annotated agenda for the next European Council meeting (19-20 December, Brussels) and took note of the presidency report on the implementation of European Council conclusions.

In December, they adopted conclusions on the review of the European External Action Service (EEAS) and the enlargement strategy and main challenges 2013-2014. They also:

- examined draft conclusions for the next European Council meeting
- negotiations with Serbia
- confirmed the agreement on the Joint Declaration establishing a Mobility Partnership between the Hashemite Kingdom of Jordan and the EU and its participating Member States.

European Council

The European Council met on 19-20 December in Brussels.

EU heads of state and government adopted conclusions on the Central African Republic, Syria, the Eastern Partnership,

Common Security and Defence Policy (CSDP)

On 18-19 November, EU foreign ministers exchanged views on the CSDP. They discussed preparations for the December European Council and took stock of the EU's current military operations: the EU's anti-piracy operation in the Gulf of Aden and off the coast of Somalia (EUNAVFOR Atalanta) and the EU training mission in Mali (EUTM Mali).

On 25 November, the Council of the EU adopted conclusions on CSDP: (1) increasing the effectiveness, visibility and impact of CSDP, (2) enhancing the development of capabilities, and (3) strengthening defence industry.

On 17 December, the EU's Political and Security Committee (PSC) approved the appointment of General Massimo Mingiardi (Italy) as the new mission commander for the EU training mission in Somalia (EUTM Somalia).

On 19-20 December, the European Council adopted conclusions on the CSDP: (1) increasing the effectiveness, visibility and impact of CSDP; (2) enhancing the development of capabilities; (3) strengthening Europe's defence industry; and (4) the way forward

European Commission (EC)

On 26 November, the EC published a communication on a European terrorist finance tracking system (EU TFTS).

On 5 December, the EC published a proposal for a decision adopted the general EU position for the opening of accession of the European Parliament and of the Council providing macrofinancial assistance to the Republic of Tunisia.

It also published a proposal for a Council decision on the conclusion of the Framework Agreement on Partnership and Cooperation between the EU and its Member States, of the one part, and the Republic of the Philippines, of the other part.

Also on 18 December, the EC and the EEAS published a joint communication on elements for the EU's strategic response to the challenges in the Gulf of Guinea.

European Parliament (EP)

The European Parliament had plenary sessions on 18-21 November and 9-12 December in Strasbourg.

In November, members adopted resolutions on Bangladesh, the Nuclear Safety Cooperation Instrument, the Multiannual Financial Framework 2014-2020, macro-financial assistance to Jordan, fair justice in Bolivia, the implementation of the CSDP and the state of play of the Doha Development Agenda.

In December, they adopted resolutions on the development of statebuilding in South Sudan, the EU-Côte d'Ivoire Fisheries Partnership Agreement, the illicit manufacturing of and trafficking in firearms, their parts and components and ammunition; the EU-Morocco Fisheries Partnership Agreement, autonomous trade preferences for Moldova, resilience and disaster risk reduction in developing countries, human rights in the world 2012 and EU policy on the matter, the EU's external financing instruments (2014-2020), EU donor coordination on development aid, the EU-Armenia agreement on the general principles for Armenia's participation in EU programmes, the situation in Sri Lanka, organ harvesting in China, the situation in the Central African Republic, the 2013 progress report on Albania, and the outcome of the Vilnius Summit and the future of the Eastern Partnership.
