## Conflict Dynamics and Drivers of Peace in the Sahel Region: Gathering Civil Society Perspectives

## Concept Note

### Background

The Sahel region faces a number of development and security challenges, which are often interlinked. While some of these challenges are specific to individual countries, others are similar across borders or are transnational in nature. Some of the issues affecting diverse communities and countries in the region relate to:

- Governance, including in relation to political inclusivity, accountability, justice, state presence and the role of security forces;
- The role of armed groups and of violent extremism;
- Social cohesion and inter-/intra-communal relations;
- Extreme poverty, livelihoods and access to natural resources and public services.

As the European Union (EU) is currently looking to adjust its engagement in the Sahel, especially on peace and development issues, this meeting will bring together civil society experts from the region to share their analysis of sources of tension and insecurity, drivers of peace and resilience, local expectations and perceptions of state authorities, the EU and other actors, and opportunities for deepened EU engagement.

#### Objective

The overall objective of the meeting is to gather civil society input on conflict dynamics and drivers of peace in the Sahel region, and to allow participants to exchange with and provide recommendations to the EU in relation to its engagement in the region.

#### Participants

The meeting will bring together around 35 participants, including 20 civil society experts from the Sahel region and officials from the European External Action Service (EEAS), the European Commission (EC) and the office of the EU Special Representative for the Sahel.

#### Format

The meeting will take the form of a day-long round-table meeting with facilitated interactive sessions in which all participants will be encouraged to provide their analysis and recommendations. Participants may be split into small groups during the day. The discussions will take place under the Chatham House Rule.<sup>1</sup>

Civil society participants will also be invited to attend a preparatory meeting the previous day.

	<ul> <li>Relations between security/conflict actors (including national armed forces and different types of non-state armed groups) and populations</li> </ul>
	<ul> <li>Populations' livelihoods and access to natural resources</li> </ul>

	Participants will be invited to discuss the capacities for peace and resilience in the Sahel region, and to share insights on positive examples and on initiatives to support.
	Questions to be discussed may include:
	<ul> <li>How should civil society and local initiatives for peace be supported, and how may social cohesion and intra- / intercommunal relations be improved?</li> </ul>
	<ul> <li>How may local and national authorities as well as international actors improve the livelihoods of populations, including with regard to their access to natural resources?</li> </ul>
	<ul> <li>What should local, national and international actors do in response to the existence and actions of violent armed groups? How may community resilience to recruitment and violence by armed groups be enhanced?</li> </ul>

	Building on points expressed throughout the day, participants will discuss how the EU may enhance and deepen its engagement in the Sahel region, including in relation to its support to civil society.

	<ul> <li>What are the key opportunities for the EU to prevent violence and support positive initiatives for resilience and peace, in particular at the local level and with regard to the existence and actions of violent armed groups?</li> </ul>
	<ul> <li>How should the EU support governance reforms and address peace and conflict issues, including relations between populations and national armed forces, in its dialogue with the governments of Sahel countries?</li> </ul>
	<ul> <li>How should the EU deepen other aspects of its engagement, in particular its contribution to the social and economic development of the Sahel region?</li> </ul>
