09h10	<p>Session 1: Germany's approach to EU foreign policy: What place for conflict prevention and peacebuilding?</p> <p>Two and a half years after the establishment of the EEAS and DG DEVCO and in the run up to the European Council Summit on Common Security and Defence Policy (CSDP) in December, 2013 provides an occasion to assess the ability of the EU to act as a peacebuilding actor in accordance with the Lisbon Treaty commitment to 'preserve peace, prevent conflicts and strengthen international security' (Article 21.2(c)). 11h15	<p>Session 2: Strengthening civilian Common Security and Defence Policy (CSDP) - using the European Council Summit in December 2013</p> <p>The European Council Summit on CSDP in December 2013 provides an opportunity to review and strengthen civilian CSDP. Military CSDP is the focus of extensive debate, sometimes eclipsing the larger civilian dimension. Germany has demonstrated its commitment to civilian CSDP most recently through the publication of a non-paper that includes suggestions on decisions that could be taken by heads of governments in December to improve the effectiveness of civilian CSDP.</p> <p>Issues to be addressed:</p> <ul style="list-style-type: none"> <li>• What is Germany's vision for the future of CSDP?</li> <li>• How can the CSDP Summit in December 2013 be used to support the development of civilian CSDP?
