- What is civil society's vision for a national dialogue in Myanmar? What should be the main objectives of the national dialogue?
- What lessons can be learned from other national dialogues?
- What topics should the Myanmar national dialogue address?
- How will the current peace process be linked with the national dialogue?
- What role should civil society play in the national dialogue? Is there agreement amongst civil society actors on the desired role?
- How do other actors (government, armed ethnic groups, political parties, Parliament) see civil society's role? How could any gaps in these two visions be bridged?
- How should the public be engaged in the national dialogue? How could the dialogue be structured to ensure that it is truly "national"?

## 11:30 – 1pm Session 2 - Challenges for a National Dialogue and for the Peace Process

This session is intended to focus on issues that could undermine the process, with an emphasis on how civil society and the EU can proactively seek to address these challenges and reduce the potential risks. It will address the following questions:

- What are the main challenges for a national dialogue in Myanmar?
- How can these challenges be addressed in order to increase the chances for an effective national dialogue?
- What are the main challenges to the wider peace process in Myanmar? What are the key conflict risks in the short and medium term?
- What mitigation strategies can be employed to prevent these risks from undermining Myanmar's peace process? How can the EU and civil society support each other's efforts to do so?

# 2 – 4pm Session 3 - EU and External Actors' Support to Myanmar's Process

- What role should the EU and other external actors play in seeking to support Myanmar's peace process? And what should they avoid?
- Should they support a national dialogue? Why or why not? Under what conditions?
- What is the planning process for EU and external actors as they design their peace process support programs? How can civil society give input on these plans? How should plans be communicated to the population?
- How can the international community avoid competition and ensure best practices in support to Myanmar's peace process?
- What are the obstacles to applying conflict sensitivity in EU support to Myanmar? How do other EU policies (development, trade, etc.) affect the EU's support to the peace process?

It is managed by the European Peacebuilding Liaison Office (EPLO), a civil society network, in co-operation with the European Commission (EC) and the European External Action Service (EEAS).
