## ***STRATEGIC FRAMEWORK***

*Art.4.3 "Pre and post-crisis capacity building"*

*Objectives as per Thematic Strategy Papers.*

*'strengthen international capacity and regional capacity to anticipate, analyse, prevent and respond to the threat to stability and human development posed by violent conflict and natural disasters and to improve post-conflict and post-disaster recovery'.*

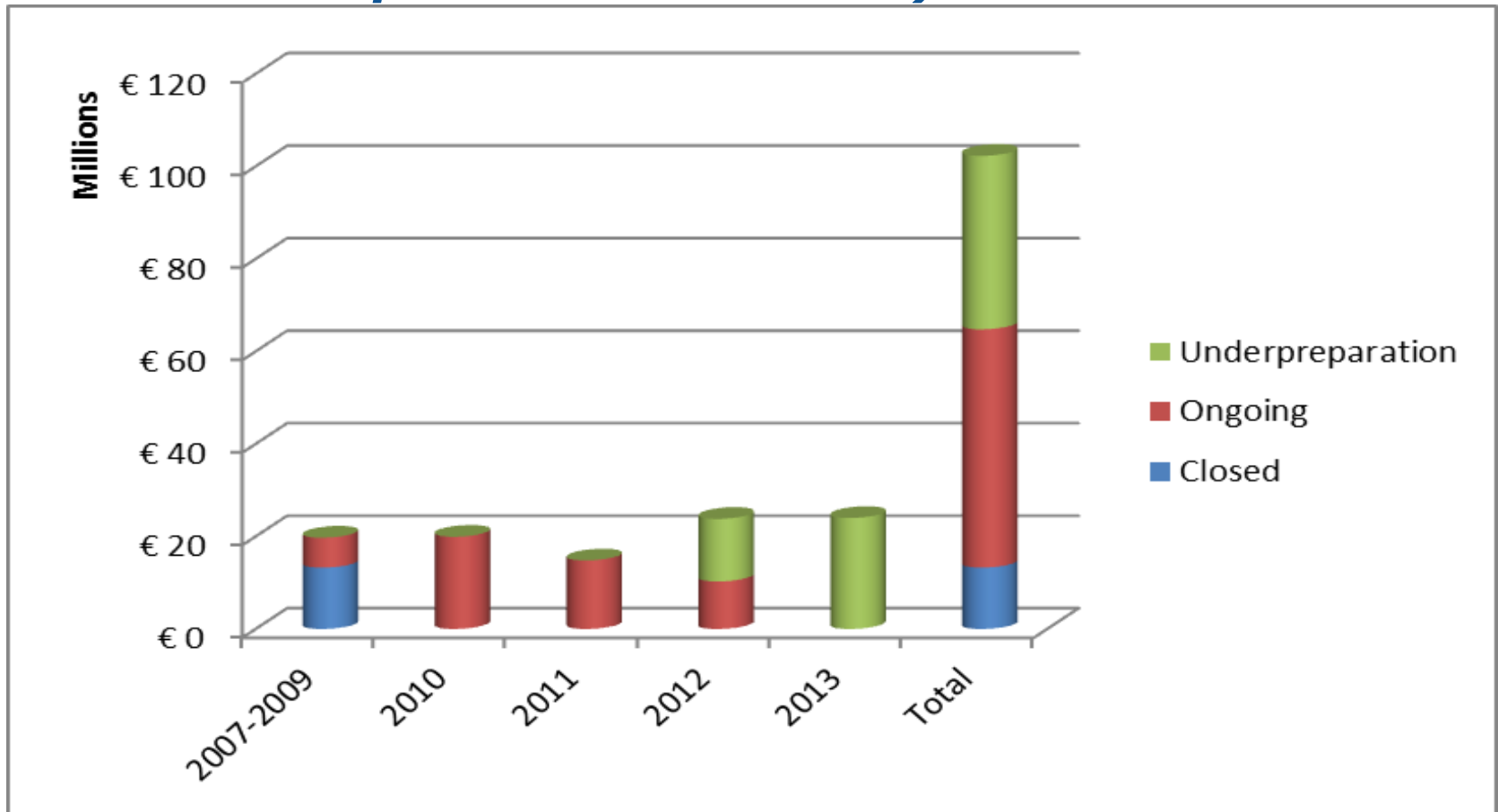
## ***FINANCIAL FRAMEWORK***

IfS Regulation, no more than 5% of financial envelope for 2007-2013 for measures under Art.4.3

=> From 2007 to 2013, a total of **103M** EUR allocated to Art.4.3 out of 2.062 billion EUR available (i.e. 5%)

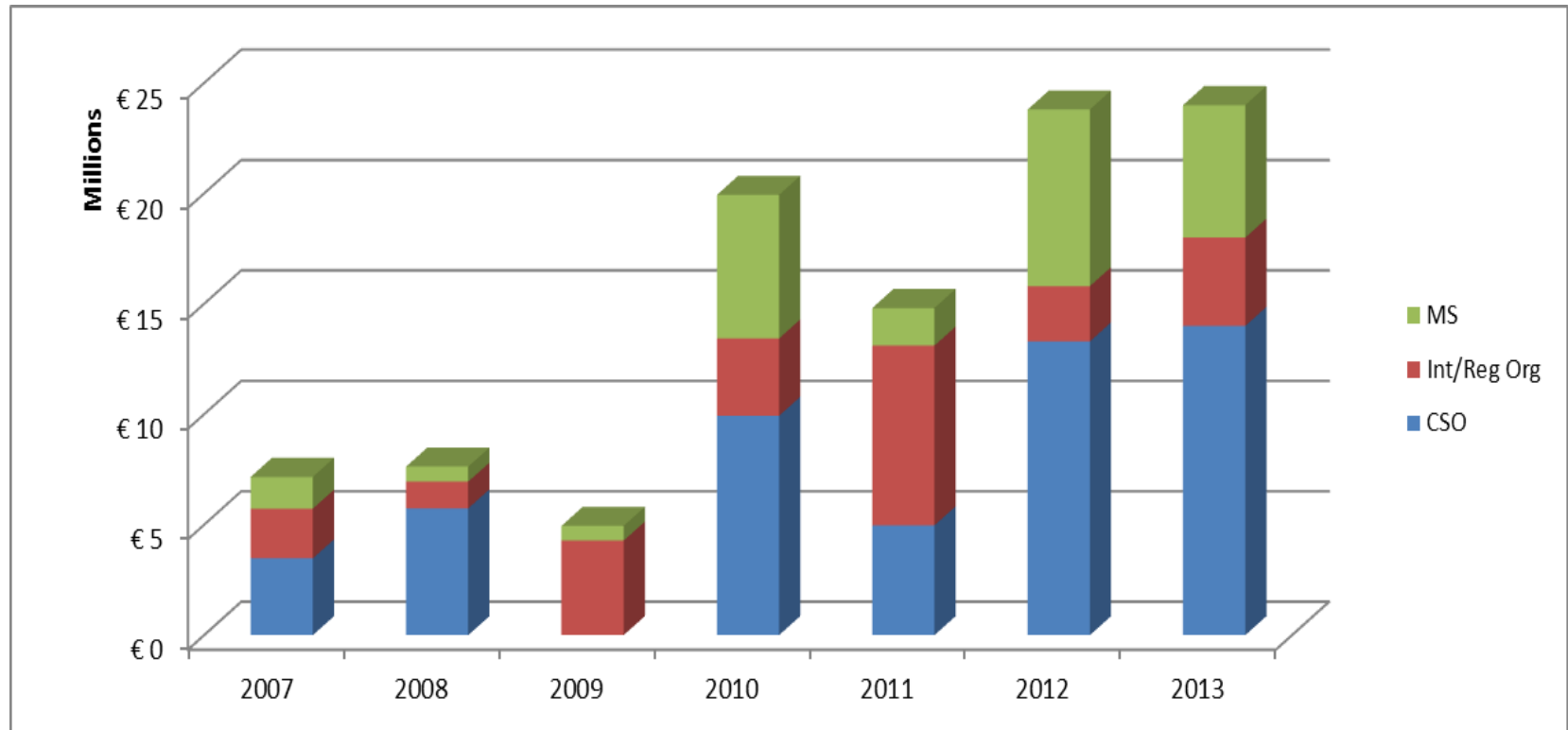
# 2007-2013 financial allocations

*(Annual Action Programmes' allocations and contracts' implementation status)*



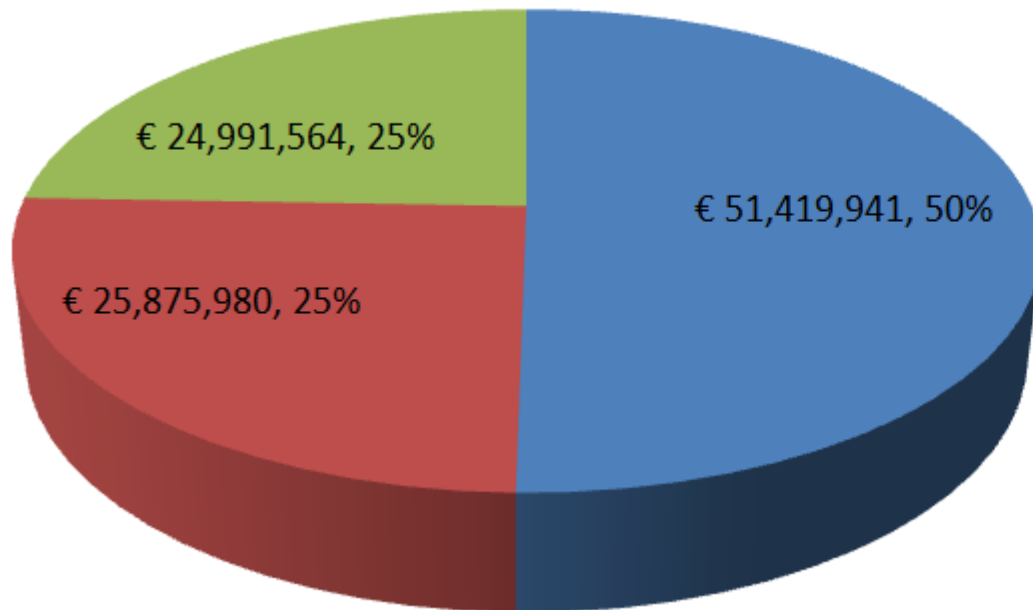

*(2007-2013 annual evolution of allocated funds)*

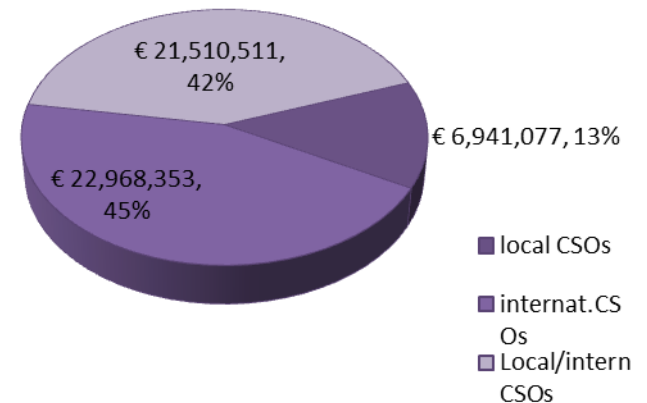

*(in % of 2007-2013 total allocated funds)*

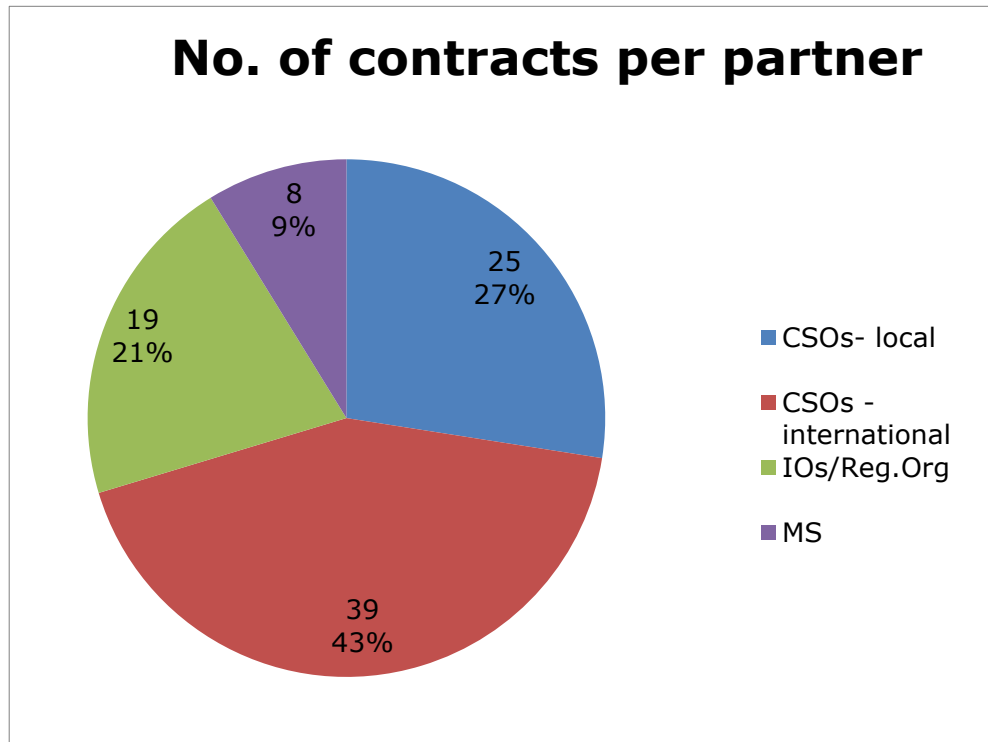

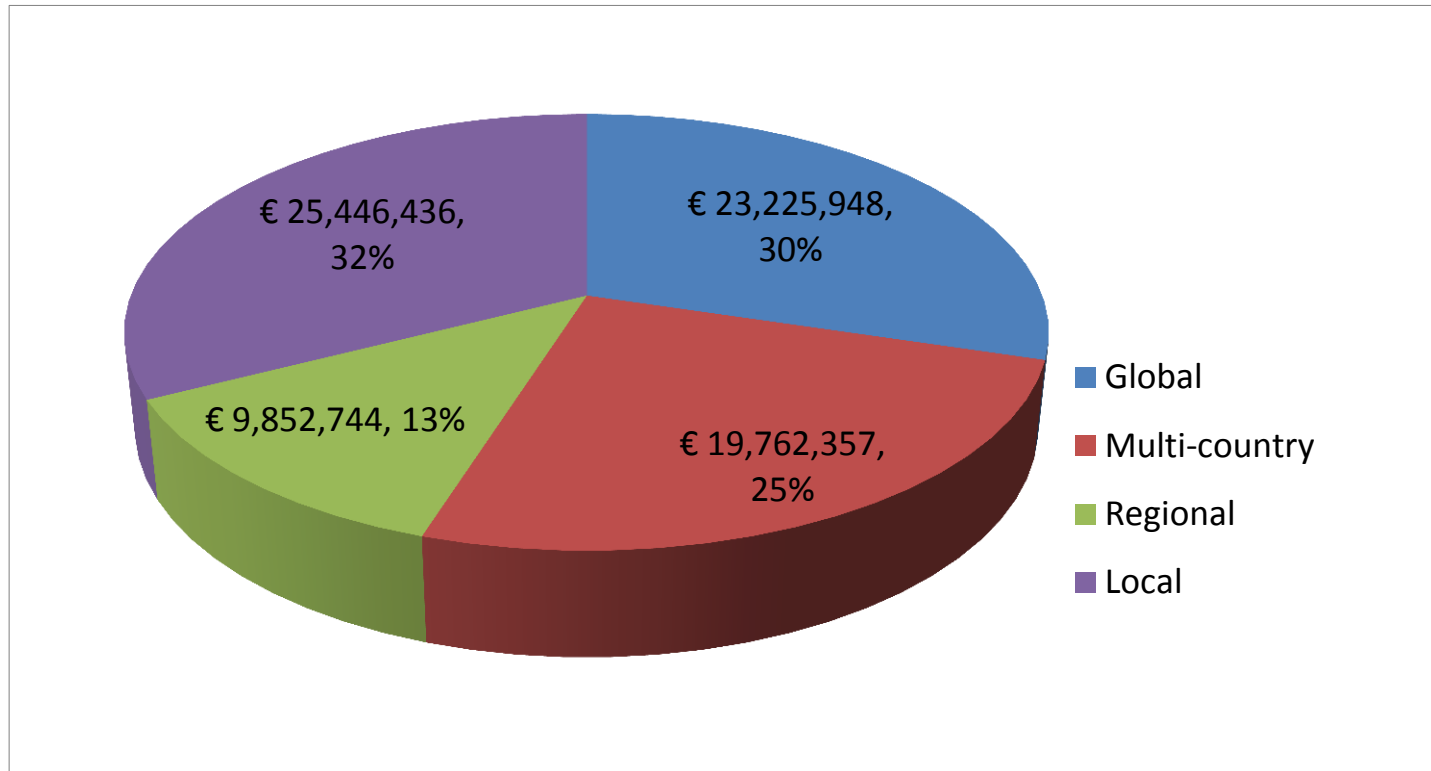

# Geographic scope of actions

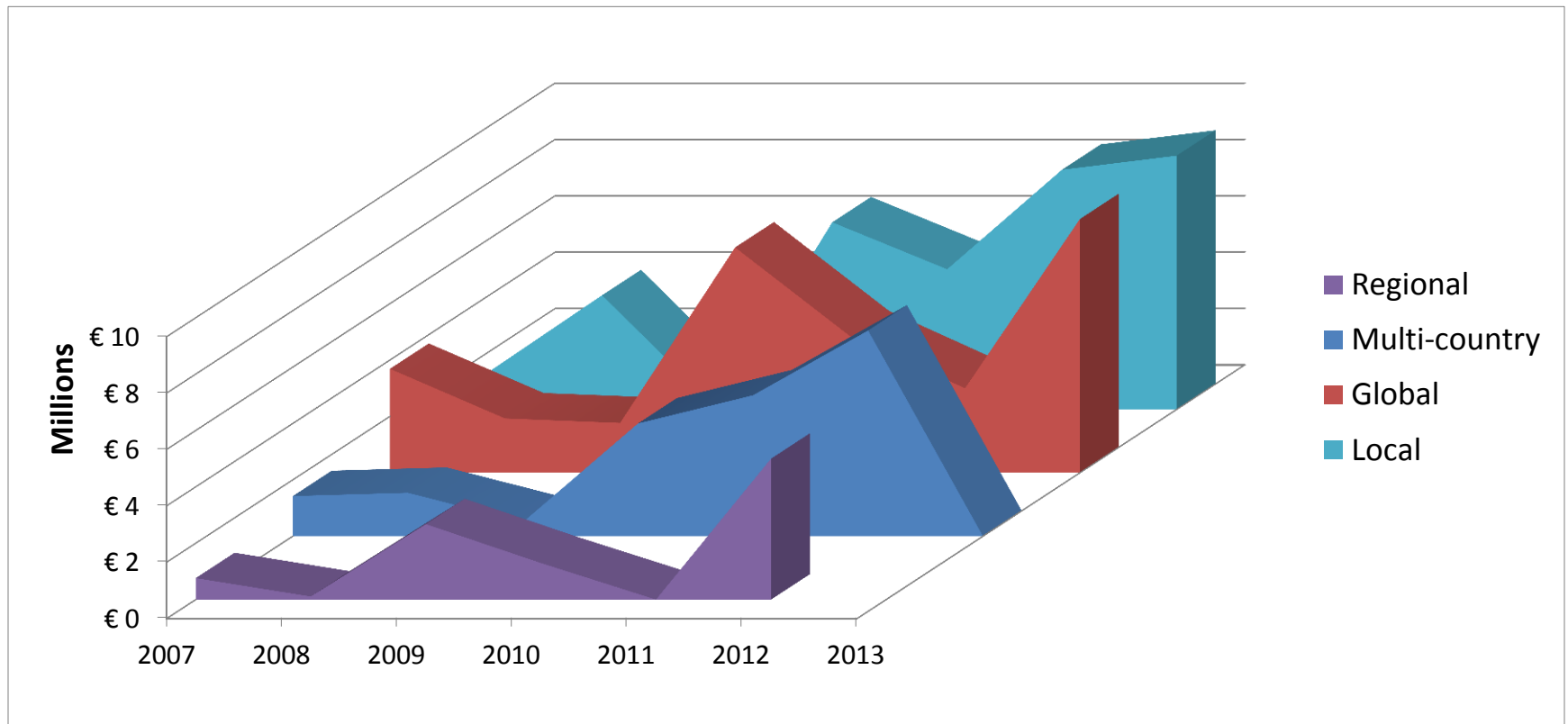
*(in % of 2007-2013 total allocated funds)*

*(2007-2013 yearly evolution of allocated funds )*

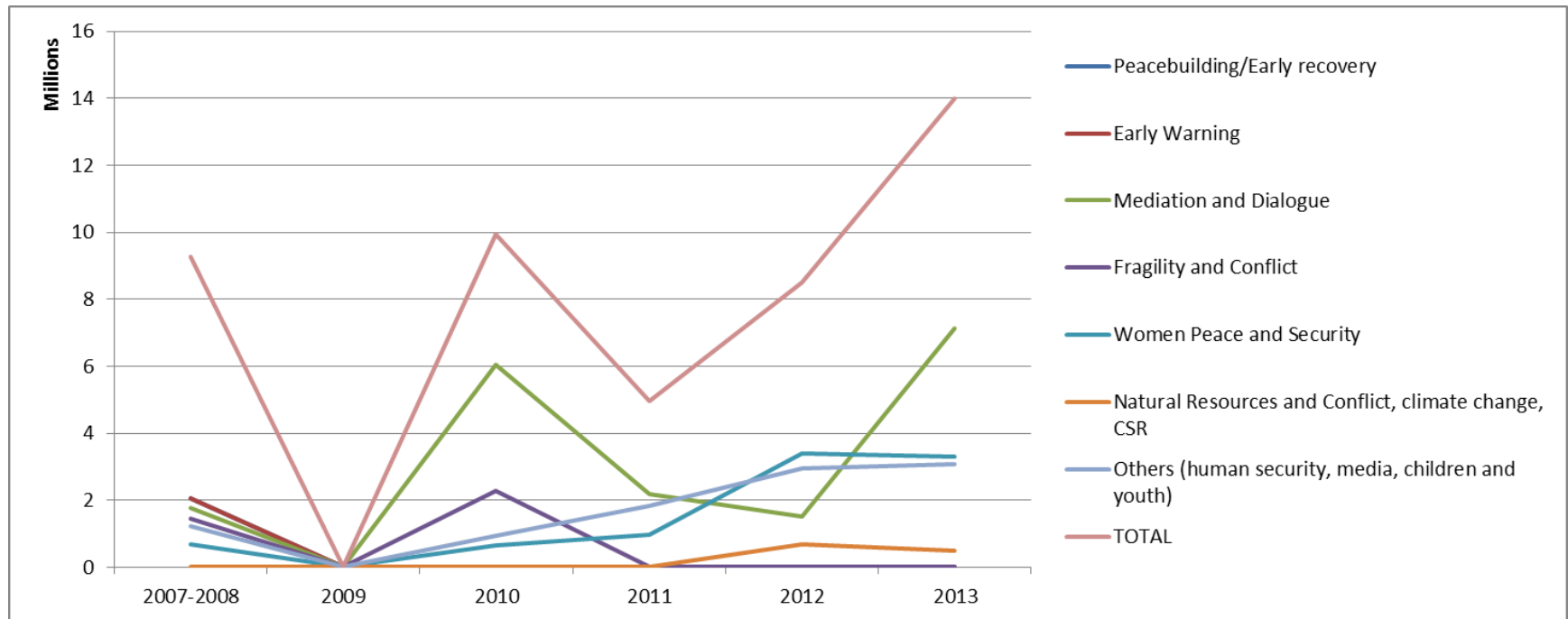

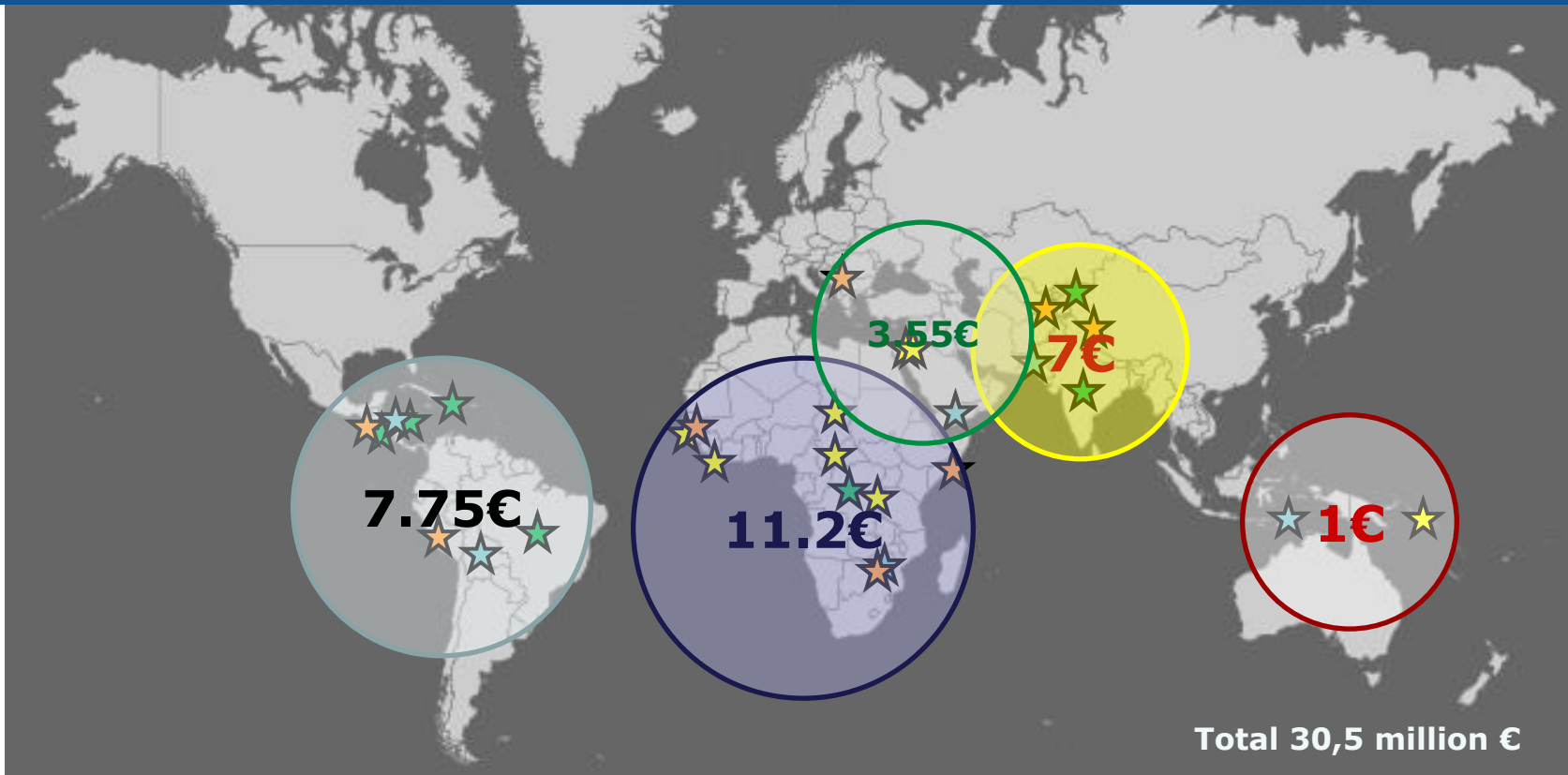

*(annual evolution of allocated funds by priority area)*



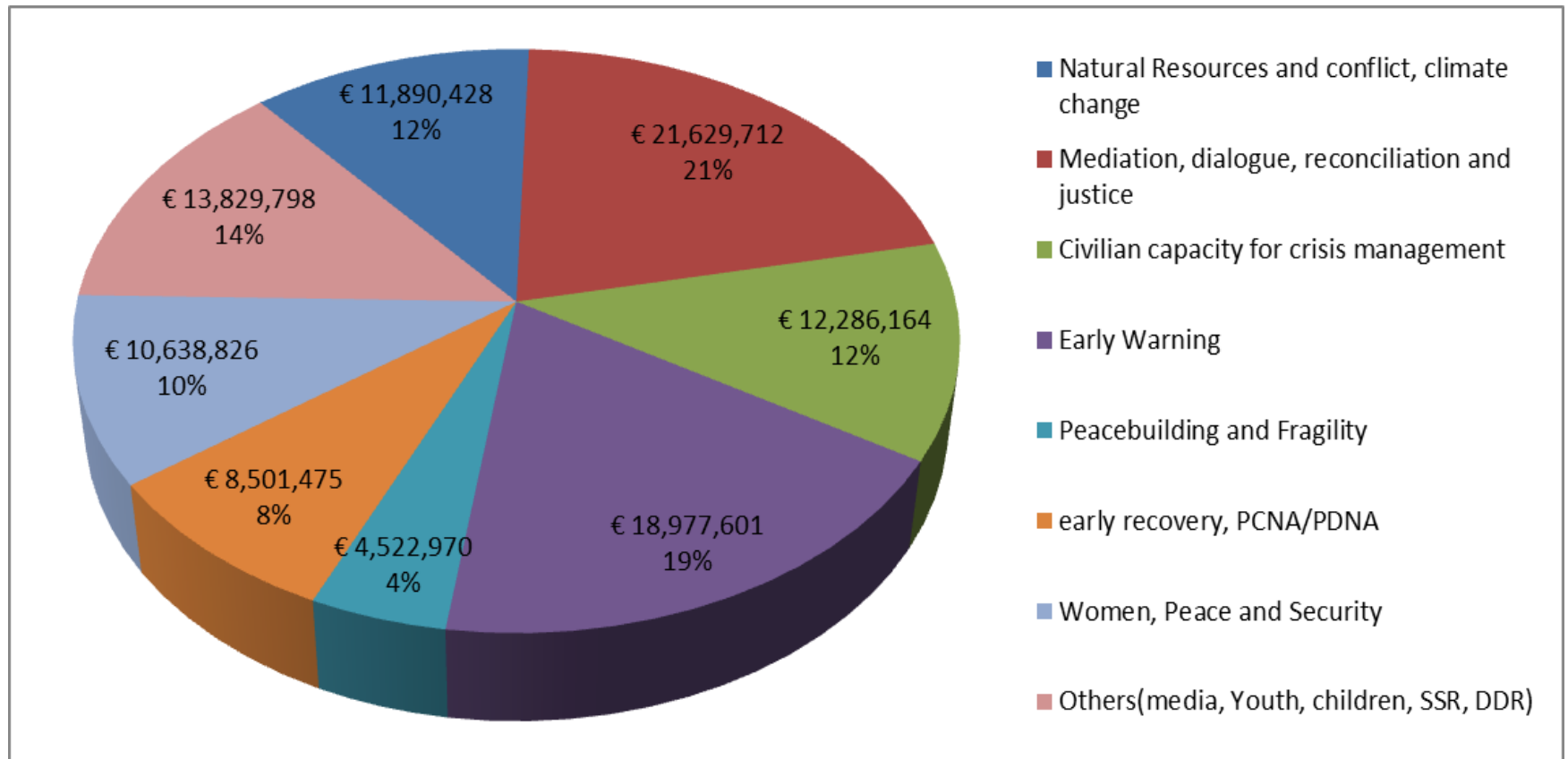
# CSO capacity-building local and regional actions

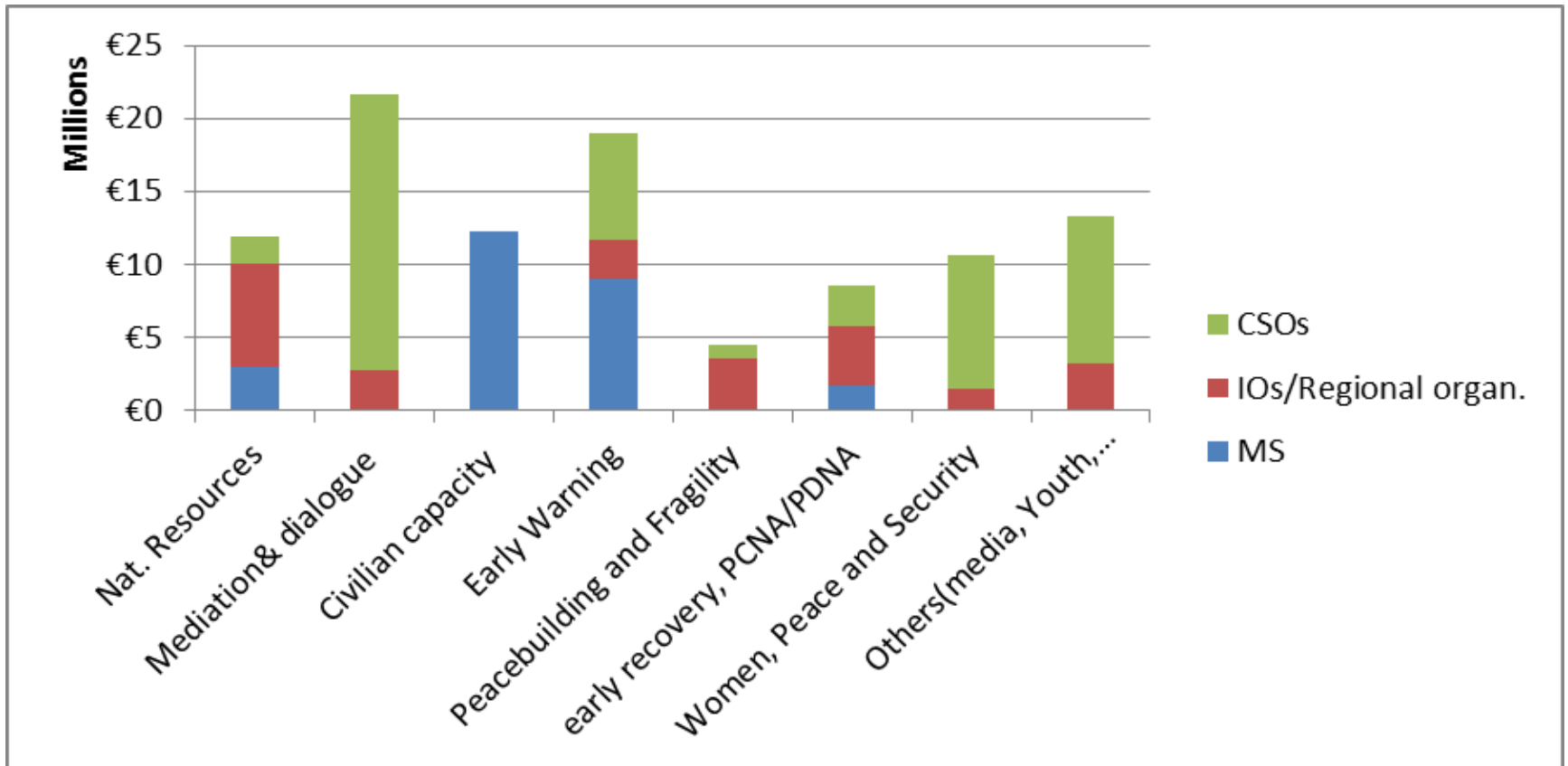
# Thematic areas of support
