Dear EU Heads of State and Government,

Re. EU Multiannual Financial Framework 2021-2027

We are writing to you in advance of the European Council on 12-13 December in order to present our **recommendations on Heading VI (Neighbourhood and the World) of the next EU Multiannual Financial Framework (MFF)**.

We are a group of civil society networks active in the fields of sustainable development, development finance, human rights, democracy, peacebuilding, social, environmental and climate justice and humanitarian aid. We are made up of hundreds of member organisations in your countries and supported by hundreds of thousands of people in Europe and elsewhere.

The next MFF should enable the EU to respond to the multiple challenges confronted by people and the planet, to deliver on the Paris Agreement and the Sustainable Development Goals (SDGs), and to ensure that no one is left behind. The EU's contribution to addressing these global challenges is overwhelmingly supported by EU citizens, and should be further strengthened. We therefore urge you to ensure that **climate action, development cooperation, human development, human rights and democracy, humanitarian assistance and peacebuilding continue to be prioritised under Heading VI**.

Almost 18 months after the European Commission published its proposal for the Neighbourhood, Development and International Cooperation Instrument (NDICI), we are increasingly concerned that the Council of the EU has not yet adopted a position on whether the European Development Fund (EDF) and/or the European Neighbourhood Instrument (ENI) should be included in it. We urge you to **reach an agreement on the structure of the proposed NDICI Regulation** so that it can be adopted in 2020 and the EU can continue to fulfil its role as a leading global actor beyond 1 January 2021.

In addition, as you discuss the MFF figures presented by the Finnish Presidency, we urge you to reconsider the following recommendations on Heading VI:

1. **Maintain the level of resources for Heading VI at no less than 10% of the overall MFF** and ensure that the integration of the EDF into the EU budget does not result in a decrease in funding for the African, Caribbean and Pacific (ACP) group of countries;
2. **Restate the EU's long-standing commitment to contribute 0.7% of GNI to official development assistance (ODA)**;
3. **Update the commitment which was made in the February 2013 European Council regarding the amount of the external action heading to be classified as official development assistance (ODA) so that at least 95% of Heading VI is ODA.**

We encourage you to be bold and visionary to ensure the EU and its Member States deliver on citizens' expectations by translating policy commitments into action.

We hope that you will take our recommendations into account during your discussions on the next MFF and we look forward to continued engagement with you in 2020.
