Concept Note

Learning objectives

The training seminar will provide participants with an **analysis** of the European Union's (EU) institutional capacity regarding conflict prevention and peacebuilding.

The overall objective of the training seminar will be

- to enable participants to increase their understanding of the EU as a foreign policy actor
- 2) to **learn about obstacles and potential of the EU** to carry out effective peacebuilding and
- 3) to provide them with **concrete examples of advocating** for more effective policies and programmes on conflict prevention and peacebuilding at EU level.

Please note that this training seminar will <u>not</u> include sessions on how to apply for EU funding or on EU grant management.

Methodology

The training seminar will consist of interactive plenary sessions and small group work, with additional opportunities for networking. It will also include a tour of the European Parliament.
